Regarding Bortondale customer count reconciliation: After a series of reviews of internal documents, billing records, field counts, and meetings with the MTSA staff, Mr. Matson has determined the value of the 'underpayment'. Since 2015, the customer count has been inaccurate in the billings. The UPTSA has underpaid the MTSA for \$34,331.52. He is recommending that the UPTSA forward a check in the amount of \$34,331.52 to the Middletown Township Sewer Authority. Invoice No. 276 dated June 27, 2022 in the amount of \$34,331.52 has been received from the MTSA. From now on, our process of updating the house list, the sewer service area map, and Chapter 94 Reports will be continuously updated.

REPORTS OF CONSULTANTS

MR. J. P. KELLY, ENGINEER

Mr. Kelly introduced Mr. Burns, noting that since he may not be attending the next board meeting, Mr. Burns will be here in his place.

The contractor for the Bortondale pump station continues to work on-site. Mr. Kelly expects the installation work to begin within two weeks.

Routine support and data collection continues with regard to One Call markouts.

With regard to sewer mapping, data is being collected on newly-installed pumps, when applicable, to be added to the web map.

ROW sewer televising is now complete. It is fairly routine that we televise everything every ten years. The contractor, Mobile Dredging/Video Pipe, is currently cleaning gravity formains in Rose Tree Estates. This is the last year of the current four-year contract and, at its end, we will have to put it out for bid again. Mr. Kelly noted that three and a half years ago, we received two bids that qualified. Easement work TBD.

MR. ERNEST ANGELOS, SOLICITOR

Mr. Angelos called attention to Item No. 15 on the voucher list, which included the check for Invoice No. 276, to the Middletown Township Sewer Authority for reimbursement of EDU differences from 2015 to 2021. He will be working with Middletown to draft a new agreement.

Regarding Orange Street, he referred to a Deed of Dedication and the need to acquire easements from the owners of the three new houses there.
