### BUILDING PERMITS

In accordance with PA Act 157, a mandatory \$4.50 educational fee will be collected for each permit application, in addition to the below permit fees

Penalty Fee for work performed without a permit in addition to the actual fee

Residential.....	\$150.00
Commercial.....	\$250.00

The Township may determine that a special building plan review is required. If it is determined that a specialized building plan review is required, the applicant shall execute a reimbursement agreement wherein the applicant agrees to reimburse the Township for any costs incurred for specialized plan reviews. Fees for specialized plan reviews are fees in addition to any permit fees or Township review fees required by any other ordinance, regulation, or resolution by the Township.

Additional fees may be imposed for the review of plans and inspections made by outside agencies, individuals, or organizations. The fee imposed shall be reasonable and will be calculated by the Township Engineer, based on the actual cost to the Township.

The Applicant, Owner or Agent will reimburse to the Township all fees paid by the Township to the Township Engineer, Planner, Solicitor, Traffic Engineer or other professional consultants for all reviews and field inspections.

portion thereof

Decks & Porches (> 30" above grade).....\$0.75/SF (\$175.00 min)

portion thereof

**USE & OCCUPANCY INSPECTION FEES**

Residential..... \$100.00

Commercial..... \$150.00

IF THE INSPECTION FAILS FOR ANY REASON, THE APPLICANT MUST PAY A RE-INSPECTION FEE WHICH IS EQUAL TO THE COST OF THE INITIAL INSPECTION PRIOR TO SCHEDULING A RE-INSPECTION.

ADDITIONAL COPIES OF AN ISSUED CERTIFICATE OF USE AND OCCUPANCY FORM ARE \$5.00 EACH; AN UPDATED CERTIFICATE WITH TRANSFERRED NAMES IS \$10.00.

**RENTAL PROPERTY INSPECTION FEES**

1 to 3 units..... \$75.00 per unit

4 or more units..... \$50.00 per unit

**ZONING HEARING BOARD**

1. **Application Fee:** Each application to the Zoning Hearing Board of Upper Providence Township shall be accompanied by an **application fee of \$750.00 for Residential applications and \$1,500.00 for Non-Residential. An initial escrow deposit of \$750.00, payable** to the Township of Upper Providence, shall also be submitted along with any application against which will be assessed the incurred cost for:

1. Legally required advertising.
2. Postage of Notification Letters.
3. Stenographer's appearance fee will be divided equally amongst the applicants.
4. Stenographer's transcription costs, where a transcription of the Notes of Testimony is requested by the Applicant or if the Applicant appeals the decision of the Board.

2. **Additional Deposits:** If it should be determined that the assessable costs will exceed the Applicant's deposited amount; a further deposit shall be required to defray reasonable costs.
3. **Accounting:** Upon final determination of the application, any unexpended balance of the escrow deposit shall be refunded to the Applicant.
4. **Implementation:** The Board, with the consent Council, may designate a Township employee, such as the Zoning Officer, to implement these provisions.
5. **Extension of Approved Zoning Order**.....\$500.00

A Storm Water Management application and permit is required for each subdivision or land development project; however, there will be no separate fee as costs are included in the application fee and escrow fund as listed above.

Escrow fund shall be used to offset costs of review and preparation of documents by Township Engineer, Zoning Officer, Land Planning Consultant, Attorney, Sewage Enforcement Officer and any outside Township consultants when applicable.

Charges shall be made on a per hour basis with the balance of escrow being returned to applicant upon project approval once final billing has been completed.

#### **MISCELLANEOUS FEES**

Contractor Registration is NOT required if contractor has a current PA Home Improvement Contractor license. A Certificate of Insurance and copy of the state license is required in lieu of fee.




