Pennsylvania law authorizes municipal governments and local school districts to impose an earned income tax with the tax rate set locally.

Effective January 1, 2025, the earned income tax (EIT) rate is 1% for residents of Upper Providence Township. The Rose Tree Media School District rate is 0% for a total EIT of 1%.

A 1% “non-resident” EIT is applicable for employees who commute to work in Upper Providence Township. If the rates for the resident and workplace jurisdictions differ, employers must withhold at the higher of the two rates.

Your business must withhold from payroll and report employee EIT to Keystone in compliance with Pennsylvania law. Quarterly payroll withholding returns and payments are due within 30 days after the close of each calendar quarter. *Make your payment by the quarterly due date to avoid statutory penalty, interest and Act 192 costs.*

Set up a Business Portal Account

- Access business.KeystoneCollects.com

Earned Income Tax

- Your Federal Employer Identification Number (FEIN)
- Political Subdivision (PSD) Codes for both the workplace location and resident municipality of each employee
- Physical addresses for each employee (No PO Boxes)
